2024 SUMMARY ANNUAL REPORT FOR NORTHERN CALIFORNIA PIPE TRADES SUPPLEMENTAL 401(k) RETIREMENT PLAN

This is a summary of the annual report of the Northern California Pipe Trades Supplemental 401(k) Retirement Plan, EIN 94-3190386, Plan No. 002, for the period of January 1, 2024, through December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the Plan are provided by the Trust Fund Office. Plan expenses were \$38,684,842. These expenses included \$927,760 in administrative expenses, and \$37,757,082 in benefits paid to Participants and Beneficiaries. A total of 4,259 people were Participants in or Beneficiaries of the Plan at the end of the Plan Year, although not all of these people had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$568,511,095 as of December 31, 2024, compared to \$504,553,405 as of January 1, 2024. During the Plan Year the Plan experienced an increase in its net assets of \$63,957,690. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$102,642,532, including Employer contributions of \$30,296,084, Employee contributions of \$13,442,045, rollover contributions of \$932,896, earnings from investments of \$57,870,757, and other income of \$100,750.

Minimum Funding Standards

Enough money was contributed to the Plan to keep it funded in accordance with the minimum funding standards of ERISA.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- An accountant's report;
- Financial information and information on payments to service providers;
- Assets held for investment;
- Delinquent Participant contributions; and
- Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the Plan participates.

If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the Plan at 935 Detroit Avenue, Suite 242A, Concord, California 94518-2501, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
